Key Responsibilities:

- **Financial Oversight**: Provide leadership in all financial matters, including accounting, budgeting, financial reporting, and audits for the Diocese and its associated congregations.
- **Budgeting and Forecasting**: Assist congregations in developing and managing their annual budgets, ensuring fiscal responsibility and alignment with best practices and mission goals.
- **Resourcing Congregations:** : Partner with congregational leaders to develop long-term financial strategies that support growth and sustainability, including investments, legacy giving, and grants from Trustees and Diocesan Council.
- **Investment Management**: Oversee diocesan investments, ensuring prudent investment of funds to maximize returns while minimizing risk, in accordance with the Diocese's ethical guidelines.
- Compliance and Governance: Ensure all financial activities comply with local, state, and federal regulations, and adhere to the Diocese's internal policies and procedures.
- Collaboration and Support: Work closely with the Bishop, Bishop's Staff, Diocesan Council, and the Trustees of the Diocese to provide financial guidance and recommendations to support decision-making.
- **Training and Development**: Provide training and resources to congregational leadership and treasurers in areas such as financial literacy, budget management and best practices..

Qualifications:

- Bachelor's degree in Accounting, Finance, Business Administration, or a related field (CPA or MBA preferred).
- Experience in financial management, preferably in a non-profit, religious, or mission-driven organization.
- Strong knowledge of budgeting, forecasting, and financial planning.
- Experience with investment management and understanding of ethical investment principles.
- Excellent communication and interpersonal skills, with a proven ability to work collaboratively with diverse groups, including clergy, lay leaders, and diocesan staff.
- Understanding of the mission and values of the Episcopal Church is a plus.
